WHO SHOULD ATTEND?

Participants should be lottery professionals across all disciplines and functions with five years or more experience including at least two years' experience in a middle management (executive) role within their lotteries.

The content would also be very useful and attractive to staff of EL partners/suppliers as well as national Gaming Regulatory staff.

All presentations and exercises/case studies will be in English and participants should have a good working knowledge of **English** to benefit fully from the programme.
