Dr Weber initiated the first mass proceeding against Maltese gambling companies in Austria and has already conducted over 15,000 legal proceedings. He sues for gambling losses against companies such as Pokerstars, Mr Green, 888 Casino, etc., with the sole argument that their Maltese license is insufficient in Austria, rendering the gambling contracts absolutely void.

Previously, she worked at an international law firm in Düsseldorf.
